



Advocacy Book Club: Purpose

Learn about Wisconsin's advocacy landscape and opportunities to engage Connect with likeminded educators and community members



Advocacy Book Club: How It Works

Anyone can join (WITESOL member or not)!

We read 2 books each year, selected by book club members.

Meet once a month, read 1-3 chapters per session

Schedule for monthly meetings:

15 minutes of advocacy updates

1 hour of book discussion





State Legislative Days: Purpose

 Events where organizations bring constituents to meet with legislators

Emphasize the importance of policy issues

Build relationships with legislators

Provide information to legislators to help them make decisions


 Advocacy is more effective with a concentrated effort

Legislative Days: How It Works

- Anyone can participate!
- Participants (with ample support from WITESOL) contact representatives
 - A contact template will be provided
 - You can pair up with another participant
 - You speak with the legislators (with a template and support) about chosen issues



Legislative Days: Timeline



- Now (Nov. 2025): Decide on topic and asks; establish bipartisan rationale for asks, recruit advocates
- **Dec. 2025**: Create documents, continue recruitment
- Jan. 2026: Begin contacting legislators to set meetings
- Feb. 2-4, 2026: Meet with legislators
- Feb.-Mar. 2026: Follow up with legislators, maintain relationships

Local Action


Advocacy can happen at every level!

Keep an eye on county board, city council, school board, and neighborhood association meetings in your area

Stay up to date on local candidates

Write op-eds for your newspapers

Keep your students and peers informed about the local landscape



Advocacy Best Practices

Tailor your asks to your audience

Be concise

Share expertise without using jargon

For public employees (and many private ones):

Only engage outside of work hours Avoid using <u>any</u> state resources

This includes email addresses, work devices, work spaces



Why is advocating for changes in legislation important?

- 1. Because no piece of legislation is perfect.
- 2. Because MLs are generally not considered very much when drafting legislation.
- 3. Because educational legislation often increases teachers' already heavy testing burden with additional testing and monitoring requirements.





Advocacy Action Days

- At the heart of national level advocacy
- Takes place twice a year, virtually (February) and in person (June)
- Participants come from all over the country.

Advocacy Action Days

- Participants are prepared to meet with their legislators/staffers.
- Participants advocate for USDE appropriations and bills that support MLEs, their families, and teachers.
- Sharing local stories that tell how funding impacts your community are encouraged!

How can you advocate?


- Whether we like it or not, education is political.


